Inspections and Violation Reconcilitation

Our neighborhood has an amazing property manager, Shonna Brown! Patty Cash is our HOA Admin who is also invaluable. Shonna often is driving in a marked car with a First Service Residential magnet. You may see her slowly driving down the street while she completes annual inspections and follows up on violations. Just a reminder, do not approach her while she is in her car to discuss a violation or concern. She will not roll her window down as it is not the appropriate place to discuss it. Also, please refrain from taking issues directly to Patty at her house. Respect her boundaries as both someone who works for our community but who also lives among us. The correct way to handle a concern with a violation is to email Patty at homesteadatcarrollton@gmail.com. She can walk you through next steps. Any violation will come as a courtesy warning first, so that is the perfect time to take it to Patty who can arrange for the matter to be brought before the board. Fines are not immediate and there is plenty of time when you receive a violation to discuss it and get questions answered to plead your case. Know that Patty and Shonna are just part of a team who help watch over our neighborhood, and we ask for your help. If you notice something that needs to be corrected, (for example, a tree limb hanging very low along a sidewalk) snap a picture and email it with the address to Patty at the above address. She will take it from there.

Helpful Information from your HOA Admin: Maintaing your Sidewalks

Thanks to COVID-19, this year has seen an increase of walkers/runners in our neighborhood at all hours of the day. The sidewalks are within the City of Carrollton right of way but the homeowner is required to maintain it. With ground shifting, there are many trip hazards such as buckling and sinking on our sidewalks. A trip hazard is defined as a vertical displacement exceeding 1-1/2 inches or a crack exceeding 1 inch in width.

To help homeowners with sidewalk maintenance, the City offers a 90/10 Grant Sidewalk Repair Program. https://www. cityofcarrollton.com/departments/departments-g-p/public-works/sidewalks/90-10-grant-sidewalk-replacement-program

This is a simple process of filling out the form to describe the location of the sidewalk. The City will come out, evaluate the sidewalk and contact the homeowner with their recommendation for repair. Your HOA has repaired a few sidewalks over the past few years. The sidewalks on Orchard Lane at Hillside Park have recently been repaired. An ACC request is not required for this repair.

Has the rain or your sprinklers caused mud to accumulate on the sidewalk? Have your trees left the sidewalk covered with leaves which are hiding potential trip hazards? I've had multiple homeowners report slipping on mud on the sidewalk. Remember the homeowner is responsible for removing the mud, leaves and acorns from the sidewalk.

Check your automatic sprinklers! With freezing temperatures, be sure your sprinklers are off. City of Carrollton Ordinance Sec. 92.60 states the homeowner is responsible for removing ice and hazardous conditions from sidewalks. Let's keep our sidewalks clear for the safety of all our residents.

The Homestead Fun Facts

Cattle or sheep in your yard? Wheat and cotton growing next door? The answer would be "yes" if you could flash back in time. This information comes from the Toews family who originally owned the Homestead property prior to it being sold for development. Mrs. Toews (who still lives in our neighborhood) recently told me they were very specific on the type of community to be built. Her family did not want cookie cutter homes; they wanted front porches and small front yards so neighbors could get to know each other. They wanted family style homes that were unique and old fashioned. So next time you walk the neighborhood and are greeted by neighbors relaxing on their front porch, you can thank the Toews family!

Do you know where Windmill Trail got its name? When the Toews farm was sold to be developed for our community, the farm's windmill and overhead tank were donated. The grass circle in front of the clubhouse is where the windmill was to be installed. Unfortunately, before installation, the windmill was stolen. Windmill Trail kept its name, but without the windmill. Check back each newsletter for more history of The Homestead.

Landscape Update

With mowing season behind us, now is the time to complete those other landscape duties, like trimming trees or planting new trees. This is the best time to remove those low limbs and also, as leaves fall, to remove any mistletoe. Just a reminder, if you see any sprinkler issues or standing water on HOA land, please let us know so that we can get the problem addressed and avoid high water bills. We have a few landscape projects lined up for this winter, including adding some median trees where we have had trees die in the past and sprucing up Primrose Park. If any homeowners are missing street trees in front of their homes, please check out the guidance on planting street trees in the HOA documents. Homes are required to have street trees to continue the shaded street and sidewalk vision set forth in the original neighborhood design documents. The guidance document discusses tree varieties and alternatives to planting between the curb and sidewalk where that area is not conducive to successful trees. Even though we barely had our first freeze, before you know it we will be glad for that shade!
